Others

A hearing was held at the request of Manheim Township seeking an additional year of eligibility for Madeline Kurtz under Article VIII, Section 6 of the By-Laws. The Committee had a stenographer present for the hearing.

After reviewing written material presented and hearing testimony from all three people the Committee went into executive session for discussion. Upon returning to regular session a motion by Hal Griffiths with a second from Don Seidenstricker was passed unanimously to deny the request for additional eligibility.

Written materials were received from Schuylkill Valley requesting an additional year of eligibility for Erick Rivera under Article VIII, Section 6 of the By-Laws. After review and discussion the Committee approved the request on a motion by Mike Craig with a second from Tory Harvey.

Charles Fortney, High School Sports Live, was present to review a written proposal to the Committee to televise all the District Basketball Finals. The Committee accepted the proposal and indicated they would consider it later during the meeting. After consideration it was decided that Sam Elias and Rod Frisco would meet with Charles Fortney to finalize concerns. They were granted authority to make the final decision.

Discussion was held on the need to make sure that all officials contracted in Field Hockey and Volleyball come from the approved lists submitted to the PIAA for state events.

There was discussion on the way that disqualifications of athletes is processed from the official to the state office and then to the individual school.
