## **Report of the Treasurer**

Spring sport game reports and expense checks are still being processed so no final report was presented. In discussion the Committee reaffirmed action taken last year to pay dues for all schools for the 2013-2014 school year. The treasurer will provide this information to the State Office and schools should not receive any invoices this year.

The report was accepted on a motion by Dave Bitting with a second from Steph Deibler.

A hearing was held at the request of Muhlenberg H.S. seeking an additional semester of eligibility for Antonio Dominquez under Article VIII, Section 6B Of the By-Laws. In attendance from Muhlenberg was Athletic Director Kerry Ciatto, the student and his parents. The request was approved on a motion by Mike Craig with a second from Dale Myers.

A second hearing was held at the request of Carlisle H.S. requesting a waiver of the Age Rule under Article I, Section 3 of the By-Laws for Dorian Naiditch. In attendance from Carlisle in addition to the student and a parent was Athletic Director George Null, Middle School Principal Collen Friend and Weight Room Supervisor Dave Eavenson. The request was approved for one semester of football on a motion by Adam Sheaffer with a second from Mike Craig.

## **Action/Discussion Items**

- Consideration is being given to setting up a District III List Server thru IU 13 that all District III school could use. At the same time consideration will be given to providing automatic up to date sport rankings after each school entry. Work will continue on this over the summer and if implemented will be explained at the joint August 13 meeting.
- League representatives were asked to submit any items they have or receive for the joint August meeting.
- Fred Isopi, Soccer chairman, presented the guidelines for the fall Girls and Boys Soccer Tournaments which were approved on a motion by Adam Sheaffer with a second from Hal Griffiths.

- Co chairman for Field Hockey will be Dave Bitting and Adam Sheaffer. Co-chairmen in Bowling will be Doug Bohannon and Pat Tulley.
- The Basketball cut off date for 2013-2014 was set at Thursday, February 6 with the scheduling meeting on Sunday February 9.
- The Committee will review game reports at the August meeting and this year at the request of the auditors require that the first ticket remaining on each roll when finished selling be stapled to the game report.
- A letter was received from the District III Leagues Council requesting a uniform procedure in the assignment of officials to District games. No action was taken at this time.
