All schools will receive letters from the Committee detailing actions to be taken to prevent future problems.

The spring Baseball report was presented by Pat Tulley followed by a Clothing report for the spring by Cindy Rinehart which showed a profit of \$1091.18 and a final sportsmanship report by Cathy Wreski which showed an increasing number of Junior High disqualifications.

- ➤ The Committee reviewed the Media Fees as listed in the Policy Manual and agreed to make no changes. In addition they stated that all banners posted and announcements made at District Tournaments are to receive Committee approval.
- Randy Umberger, Wrestling Chairman, presented timeline information relative to wrestle backs in the District Team Wrestling Tournament. This was approved on a motion by Mike Craig with a second from Dave Bitting.
- ➤ A Power rating update was provided to the Committee by Rod Frisco.
- ➤ Pete Fackler, Program Chairman, provided information on the preparation and distribution of the District Football Program for this year.
- ➤ Mike Wilkes presented detailed information on the advantages for the District to join in the Max Preps Program,
